TRADING DAYS Every Thursday, and Friday

TRADING TIMES: 9.00 am – 5.00 pm.

SET UP TIMES: 6.30 am – 8.30 am.

PACK UP TIMES: 5.00 pm – 7.00 pm.

LOCATION: Located in Oxford Street Mall Bondi Junction.
Vehicle Entry via Newland Street.

STALL FEES: 3m X 3m Tent Stall: **\$95.00**

2.4m Table Stall: **\$90.00**

3m Hot Food Stall: **\$152.00**

EQUIPMENT HIRE: 2.4m Table: **\$11.00 per day**

3m Tent: **\$16.00 per day**

Tablecloth: **\$6.00 per day**

STORAGE FEES: Single large item: **\$21.00 per week**

Market Trolley: **\$32.00 per week**



POWER: Power is available on request.

VEHICLE

DROP OFFS: Vehicles may drive into the Market area during set up and pack up times.
Enter Oxford Street Mall via Newland Street and exit is also out of Newland St.

FINDING YOUR

STALL: Market staff will be located at the Market Area.
They will confirm your arrival and direct you to your Stall.

WHERE TO PARK: Paid parking is available in a number of shopping centre car parks adjacent to the mall. Street parking is also available but will involve a short walk back to the market. Further information regarding car parking is available from staff onsite.

NOTE ON SET UP

AND VEHICLES: When UNLOADING, it is essential that you unload your vehicle and take the car off the market area BEFORE you set up your stall.

FLOOR

COVERS: All hot food/ready to eat food traders must bring floor covers. Some points to remember when selecting your floor covers;

- It must cover the entire cooking and food prep area of your stall preferably 3m x 3m.
- Liquids do not easily leak through it.

If you don't bring appropriate floor covers, you will not be allowed to trade. Stallholders may also be asked to cover any costs incurred as a result of cleaning their stall area.



WASTE

REMOVAL: Garbage bins are provided for waste generated by the public not by Stallholders. You must take your waste and packaging back with you. Please ensure no liquid waste is poured into any drain, you must bring a canister and dispose of it responsibly.

PACKAGING: In accordance with Waverley Council Policy all packaging and bags must be made of biodegradable or recyclable materials. Plastic bags are not permitted.

INSURANCES Please note it is a strict requirement that stallholders must have a public and product liability policy with a minimum of \$10,000,000.00 cover in the name of the person or entity that has been approved to trade at the Market.

A copy of the Insurance Certificate of Currency must be supplied to the Manager before a stallholder may trade at the Market. It is the responsibility of the stallholder to ensure that the insurance is renewed and remains current for the term that the stallholder undertakes trading activity at the Market.
